MINIMUM ENTRY REQUIREMENT

- 2. Passed Certificate of the Malaysian Insurance Institute (CMII) from Malaysian Insurance Institute; OR
- 3. Passed Certificate in Insurance from Chartered Insurance Institute, United Kingdom.

ACCREDITATION OF PRIOR LEARNING & SUBJECT EXEMPTION

- Subject exemption may be awarded for prior learning (qualification related) by applying the exemption for the related subject(s) with the necessary supporting documents.
- 3 credits per subject for AMII Level 1 and 4 credits per subject for AMII Level 2 may be awarded if it complies with the exemption requirements.

- Students with a recognized qualification in the relevant field will be given credit exemptions based on past results and portfolio review (where applicable).
- Any other qualifications will be considered on a case to case basis.
