1. Minimum requirement:

PCEIA & PCIL:-

SPM/MCE with 5 (five) passes inclusive Bahasa Malaysia subject or other qualifications deemed equivalent or higher and it must be academic-based.

A scan color copy of certified certificates is required to be attached.

CEILLI :-

Candidates who intend to sell investment-linked products but must first be contracted as life agents.

2. Registration

- Online registration is to be done through www.mii4u.org.
- Based on first come first serve basis and on availability seats before examination closing date.
- A candidate who wishes to sit for Part B or Part C only must successfully complete Parts AB (General Insurance route) or Parts AC (Life Insurance route) before register the examination.
- Withdrawal, cancellation, and postponement of the examination are not permissible, and no refund is available.

3. On the Examination Day:-

- Candidate is required to produce his/her **original Identity Card (NRIC)** during the verification session. Failure to do so the candidate will NOT be allowed to sit for the examination.
- The candidate will receive Zoom Meeting link between 24 – 48 hours before the commencement of the examination. **Please check email "Inbox" or Junk/Spam Folder.** Candidate may also refer to the venue field on confirmation slip for the Zoom link.
- Candidate must login the Zoom Meeting **not later than 30 minutes before the examination time starts.** The candidate will be considered as "absent" if failed to be in the "virtual examination room" by 30 minutes before the examination time. The Institute reserves the right to disallow the candidate from taking the examination if the candidate is late. Please note that we **will NOT entertain** any late candidate after the entrance for examination is closed.
- Candidate must adhere to the **examination space requirement**; i.e must be in a room. Sharing room or in open public space is not allowed. If the candidate is taking the examination in the office or agency office, it also must be in a room, in an office cubicle is not allowed. To avoid any interruption during the examination, the candidate must make sure the internet line connectivity is high and good and able to meet the minimum bandwidth requirement.
- To sit for the examination, the candidate must be ready with a mobile phone and a laptop/PC.
 - (a) Mobile phone**
 - to login to ZOOM meeting
 - must in good audio and video condition
 - battery in full capacity

If during the examination, irrespective due to any reason, the candidate is being log out from ZOOM meeting, therefore the candidate is required to re-login as soon as possible within 5 minutes, otherwise the candidate will not be allowed to continue the examination and will be disqualified. However, the candidate is allowed to re-register the examination with fee.

(b) Laptop/PC

- must be in good condition and battery in full capacity
- equipped with **Windows 10** and **Google Chrome**
- with **Security Browser (SB)** which candidate is required to download at least 1 day before the examination time.

No consideration will be given if candidate failed to meet the above requirement where the candidate will not be allowed to sit and proceed with the examination. No reschedule of examination will be considered, however candidate is allowed to re-register the examination with fee.

BAMC REQUIREMENTS:

Successful completion of the Basic Agency Management Course depends on satisfactory performance in three (3) areas, namely Attendance, Moderator's Grade and Examination.

1. Attendance :

The requirement is 100% attendance at class sessions. Failing to achieve this will disqualify you from taking the examination.

2. Moderator's Grade :

This is a grade given by Moderator to a candidate for the candidate's class participation and completion of questionnaires and action projects.
