9. Withdrawal or Cancellation from Examination

Any request for postponement, cancellation, or withdrawal from the examination before the examination closing date must be submitted in writing and is subject to approval by the relevant authorities. Upon approval, the candidate will be entitled to a 50% refund of the examination fee.

Please note that strictly no refund of fees, and no substitution or replacement of candidates, will be permitted after the closing date.

If a request is submitted after the examination closing date, a 50% examination fee will be charged. However, such requests must be submitted before the examination e-permit notification is issued.
